lan Carsten Scholarship recipients: Congratulations to Zane Johnson (SBA), and Arielle Brotman (RSD) for having the top HS senior 200Y Fly times. These swimmers were recognized at the June Splash and Dash meet. Each received a plaque and will be given \$1,000 scholarship award as they move to continue their swimming in college.

**Don Watkinds Scholarships** will be recognized at the SI LC Championship this week. Names to be listed at the subsequent BOD meeting (We don't want to spill the beans prior to the meet).

#### Planning:

The financial planning meeting had to be bumped to August due to the availability of those involved. ## **Finance Report:**

Green & Associates prepared and filed the Federal and State Returns required for Tax Exempt Organizations in June for San Diego Imperial Swimming for fiscal year end September 30, 2023. Matt Krehe, CPA of Gilbert CPAs has been engaged to conduct the Agreed Upon Procedures (audit) for SI Swimming's fiscal year ended September 30, 2023. This audit is required by the LSC Affiliation Agreement with USA Swimming. The engagement is currently underway and we hope to have it completed within the next few weeks.

We have secured a USA National evaluator for the 2025 Speedo Carlsbad Sectional meet – Scheduled for Feb 27-Mar 2, 2025.

### **Age Group Report:**

Plans are going forward for the WZAG Championships. Airline tickets have been purchased, hotel rooms have been booked, 4 vans have been ordered, and we are working on the food for the athletes.

At this time, it looks like 10 and under, girls and boys, will have less than 4 swimmers who have at least one cut for the meet. We also have more than eight swimmers who have 4 cuts or more. Head Coach John McGlynn and I would like to request that we expand the 13-14 age group to have more than 8 swimmers: up to 12. We will keep the team size to 48.

10/U girls - 2 11-12 girls - 7 13/14 girls - 21 10/U boys - 1 11/12 boys - 7 13/14 boys - 12

Not knowing will apply or not will make the selection unknown until the applications are turned in.

*M/S/A/P Expand the 13-14 age group teams to a max of 12 swimmers per gender and keeping the entire Zone Team to 48 total swimmers.*

Thanks again for all the support. Carlos Davila -- Operational Risk

Bob Horne shared that at this weekend's Cal State Games at UCSD, a swimmer injured his shoulder and Bob is not sure if this needs to be reported since this was not an LSC meet. The meet however was an approved/sanctioned meet. Bob will email Carlos and cc Dave Kilmer on the email providing the incident information and to seek clarification on reporting. However, it was noted that the LSC should likely approach this by erring on the side of caution and report.

**Program Committee Report:** The Short course meets were awarded to teams last week.

Vote 1 required: to accept host teams as presented by the program committee.

Before vote held, two items regarding the schedule were discussed:

- 1. 10/25-10/27 meet site #2 is going out for re-bid
- 2. 2/7-2/9 meet: can this be a 2-site meet as last year this meet was large with 900 athletes? Dave pulled up meeting minutes from May 2024 and saw that this weekend was approved as a 2-site meet.

Mary can put these two weekends out for re-bid for the 2<sup>nd</sup> sites, however she noted SBA had submitted a bid for the 2/7-2/9 weekend. She will approach SBA to ask if they want to submit. Also, SDSA/Paul Folts did not oppose the 2/7-2/9 meet be split into 2 sites, as SDSA was awarded this meet as 1 site.

M/S/A/P: approve meet schedule as proposed with 2 weekends of 10/25-10/27 and 2/7-2/9 to go out for re-bid

Vote 2 required: to allow program committee to award the second site for the Oct 25-27 meet if it any teams submit a bid in the rebid process.

M/S/A/P Program Committee shall award the second site for both the 10/25-10/27 and 2/7-2/9 meets if any teams submit a bid in the rebid process.

### **Update from USA Swimming:**

Coaches that were registered before 9/1/22 will no longer be required to take the following courses as they are grandfathered in: QFC: Quality Coaching Framework, Welcome to USA Swimming, Rules and Regulations and CORE Certification.

All coaches registered for the first time after 9/1/22 will be required to take the courses.

#### The Registration Fees for 2025 will remain the same as the 2024 fees.

#### PROPOSED LEGISLATION AT USA SWIMMING ANNUAL BUSINESS MEETING

(This is for information – Since the next SI BOD meeting will be prior to the USA swimming annual business meeting, we will discuss this and additional potential rule changes at the September meeting for LSC advisement to the SI voting delegates)

New proposed fees that will affect all teams: This will be voted on at the ABM in Sept. We have 4 individuals from our LSC that will be voting on this. Currently the annual club registration fee is \$70- new or renewing.

Proposed by: Ira Klein and Kenneth Chung Purpose: To increase the annual club fee to increase the Sport Development budget so that we can maintain and increase the services provided to all clubs at all levels. Effective Date: September 1, 2025 RESOLUTION OF THE HOUSE OF DELEGATES

TO INCREASE THE ANNUAL CLUB FEE Whereas, the annual fee for existing club teams will increase to \$275.00 per year. Whereas, \$50 from this annual fee will be distributed back to the LSC. Whereas, the additional \$155 increase over the existing annual fee will be utilized in the Sport Development budget through the 2028 registration year. Whereas, the club fee for new club teams to USA Swimming will be \$750 for their first three years. USA Swimming Staff may determine reduced fees for new clubs based on outreach membership and geographical isolation.

Now, therefore, be it resolved that the USA Swimming House of Delegates approves the annual club fee for year-round clubs to be \$275 and

Mary highlighted this proposed legislation change as it affects all teams plus any new club teams. It was asked and clarified that the proposed \$750 fee for new teams is in fact \$750 per year for the first 3 years. Changes, if approved, will be effective 9/1/2025.

This is just one of the proposed changes. A Summary of all proposed changes will be sent out for review before the September 2024 BOD meeting.

**Old business:** Revisit and vote on the tabled vote for next year's host for Senior Classic. This will be a controlled discussion and vote. Those wishing to speak on the topic will receive up to two minutes to speak. The recommendation in May from the program committee was that the meet should return to being LSC hosted. Also see recommendation from coaches meeting referenced earlier in these minutes under coaches rep.

*M/S/A/P*: Untable the prior vote to allow discussion regarding Senior Classic and who to host.

General Information offered:

- A lot of history with this meet. LSC has been hosting for 35+ years likely.
- After last BOD meeting in May, Mary sent an email survey out to all head coaches asking for their input on if this meet should be LSC-hosted or team-hosted. She received very few responses (about 8 only) and this is why a coaches meeting to be held at Splash & Dash was called.


Questions/Discussion points from Melissa Eisenhamer/CSTE:

- When was the survey done/emailed out? CSTE coaches do not remember receiving.
   ✓ One coach in attendance confirmed the email survey was dated 5/22/24.
- 2. Melissa had sent an email to Dave with several subjects including this one to which she did not receive a response. Dave acknowledged remember seeing the email and apologized for not responding.
- 3. Why did the coaches meeting at Splash & Dash only have 12 attendees? CSTE coaches were not aware of this meeting. What was discussed?
  - ✓ Several announcements were made at Splash & Dash that this coaches meeting was happening Sat. during the break
  - ✓ Discussion at the meeting included part history of the meet, the importance of maintaining consistency of the meet from year to year, the addition of increased fees by CSTE and that the focus should always remain on the athletes and that the BOD should continue to do what is best for the LSC and athletes.
  - ✓ Some of the increased fees requested was \$6,000 for warming tents/additional tents, and \$1,500 for porta potties, neither of which were present at the meet.

Questions/Discussion points from Hugo Camarillo/SBA:

- 1. Our venue (Mater Dei HS) is a limitation for us to host but we know it can be done. SBA has the manpower, the school campus has lots of parking, the pool has a new scoreboard and blocks, and there are several hotels in the area.
  - ✓ Dave acknowledged SBA is a team interested in hosting this meet, but we needed to remain on the purpose of the discussion which was to determine if Senior Classic was to be an LSC-hosted meet or a team-hosted meet.

Topic went to vote. A blind vote via Survey Monkey was set up for all Board members to vote. Results were 100% that Senior Classic be hosted by the LSC. See screenshot of voting results below.
